- the production, cultivation, growing and harvesting of any agricultural or horticultural commodities
- the raising of livestock, bees, furbearing animals, or poultry
- dairying, forestry, and lumbering operations
- any work performed on a farm, as well as tasks that support or are connected to farming operations
- delivery and preparation of commodities for market or storage

Examples include any work in wineries, vineyards, dairy, or **any** other agricultural business.
